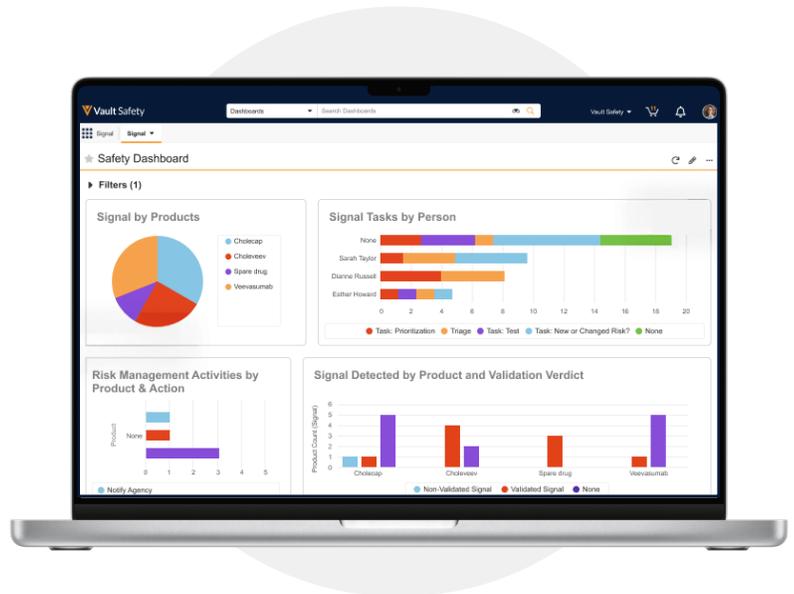

Seamlessly document signal-related activities, such as investigations, for traceability and to reduce risk and improve inspection-readiness.
